Prince of Songkla University allocates the financial support for graduate student of Pattani Campus who would like to present a paper at an academic conference for the fiscal year 2021. The details of funding are as follows:

1. Funding Specification

The expenses that is to support for presenting a paper form thesis/dissertation, will cover the registration fee, traveling cost, and accommodation for a graduate student of every Faculties at Prince of Songkla University, Pattani Campus.

2. Applicant Qualifications

The qualified applicant should be a Master or Doctoral Degree student of a faculty at Prince of Songkla University, Pattani Campus whose thesis/dissertation has been approved and the paper was accepted to present.

The student can submit a request for this funding not more than 1 time/person/year, furthermore the student can apply for a financial support from the faculty

3. Funding Value : The amount of 250,000 Baht separates in 2 categories as:

3.1 Paper oral presentation in English not more than 6,000 Baht

3.2 Paper oral presentation in Thai not more than 3,000 Baht

4. Application Date

The application date is from 1 October 2020 – 30 September 2021 or until there are fully grantees followed by the item No. 3.

5. The Application Criteria

The completely filled out application form attached with the specific documents submitted by the faculty will be selected in order of receiving or until it is covered the whole amount of funding following Item No.3.

6. The Funding Application

The following documents should be submitted to the Research Innovation and Academic service Office Academic and research Administration division Pattani Campus for approval before the date of traveling, verify by the receiving stamped date from the
× Research Innovation and Academic service Office.

6.1 a completed Application Form signed and submit for approval by an advisor, Department and Faculty respectively

6.2 an acceptance letter for paper presentation from the host of the Academic Conference

6.3 a manuscript/paper for presentation as specified on the Item No. 6.2

6.4 the student who went to present a paper is not eligible to apply for this funding

An applicant should identify the expenses follow by the financial regulation and the Announcement of the Funding rules

7. Funding Disbursement

The following disbursement documents should be submitted to the Curriculum and Faculties Development Office, Educational Services Division, Pattani Campus within 30 days after the presentation returning date, verify by the receiving stamped date from the Research Innovation and Academic service Office.

7.1 a funding disbursement form attached with the receipt follow by the financial regulation, submit to the Department and Faculty for approval, then submit to the Research Innovation and Academic service Office

7.2 the paper reprint published in the proceedings

7.3 the receipt

7.4 a certified copy of the first page of the Siam Commercial Bank PCL., Prince of Songkla University (Pattani) Branch, or Krungthai Bank PCL., Charoenpradit Branch, passbook, clarify the account number of the project leader student

8. In case of any process that is unclear, exclude in this announcement, but it is needed to proceed, the President of the Research Funding Management Committee, Pattani Campus should analyze and make a decision for further process.

3.2 Paper oral presentation in Thai not more than 3,000 Baht

4. Application Date

The application date is from 1 October 2020 – 30 September 2021 or until there are fully grantees followed by the item No. 3.

5. The Application Criteria

The completely filled out application form attached with the specific documents submitted by the faculty will be selected in order of receiving or until it is covered the whole amount of funding following Item No.3.

6. The Funding Application

The following documents should be submitted to the Research Innovation and Academic service Office Academic and research Administration division Pattani Campus for approval before the date of traveling, verify by the receiving stamped date from the Research Innovation and Academic service Office.

6.1 a completed Application Form signed and submit for approval by an advisor, Department and Faculty respectively

6.2 an acceptance letter for paper presentation from the host of the Academic Conference

6.3 a manuscript/paper for presentation as specified on the Item No. 6.2

6.4 the student who went to present a paper is not eligible to apply for this funding

7. Funding Disbursement

7.2 the paper reprint published in the proceedings

7.3 the receipt

7.4 a certified copy of the first page of the Siam Commercial Bank PCL., Prince of Songkla University (Pattani) Branch, or Krungthai Bank PCL., Charoenpradit Branch, passbook, clarify the account number of the project leader student
